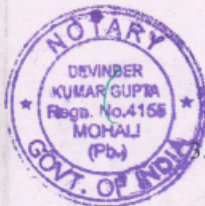

Subject :- Regarding Allotment to land for School.

Reference : Your Letter No. _____ Dated :- 14-03-1983.

In reference to your letter, you are inform about preliminary conditions before allotting you land in SAS Nagar (Mohali) for establishing Higher Secondary School which shall be kept in mind at the time of conceding the case.

1. That 2 Acres. (Two Acres. Maximum) land will be allotted for Higher Secondary School on lease hold basses for 99 years. The premium of which will be recovered @ Rs. 100/-per yards from the allottee.
Above land will be used for establishing the above school only at the earliest.
2. 25% of amount of premium of land will be payable by the allottee at the time of allotment and remaining amount will be payable in four annual installments along with 10% annual interest. Besides this allottee will have to pay ground rent also equal to premium for first 33 years @ of 10% per year , next 33 years @ 20% per year and reaming 33 years @30% per year.
Allottee has to deposit an amount equal to 25% of total expected constriction cost on building with Punjab Housing



Development Board before delivering possession to allottee. This amount will remain with the board until 50% of the total cost on constriction is spent by the allottee. After that board will refund the 25% amount along with 10% annual interest.

4. Allottee will be liable to pay penal interest also as decided by Housing Development Commissioner, Punjab Housing Development Board / Chief Administrative , Urban Estate Punjab in case of any amount is not deposited by the allottee in time.
